

# **Speaker Bios**

#### Dr. Patrick Burke

Dr. Patrick Burke has over thirty years' experience of working with people experiencing poverty and social exclusion. He has worked for many years with volunteers and other professionals in the area of social justice and human rights in South America, Europe and Ireland. Since the early 1990s he has operated at a senior management level in the community and voluntary sector, culminating in over 20 years as Chief Executive Officer of large, and complex Irish voluntary organisations operating in the areas of homelessness, housing, income deprivation, poverty, social exclusion and social and economic issues which impact on the lives of disadvantaged young people, their families and communities. He is currently the President of ERYICA, the European Youth Information Counselling Agency. He holds a PHD in Governance from the School of Law, Queens University, Belfast, Northern Ireland.

#### **Aoife Cartwright**

Dr Aoife Cartwright is a research and evaluation specialist working at the Centre for Effective Services (CES). Aoife has worked on a range of national evaluations and reviews at CES, in areas such as early years, community health and education. She is currently leading on a review of youth information provision in Ireland, commissioned by the Department of Children, Equality, Disability, Integration and Youth. Aoife holds a PhD and MSc in Psychology from Maynooth University. Prior to joining CES, she worked in research and project management in the non-profit sector

### **Marie Cleary**

Marie is the founder and director of Thirdspace Consulting. She specialises in the design and delivery of strategic management interventions which include; organisational reviews, facilitation and strategic planning, high-performance team-building and leadership development. Maries' clients span a range of sectors including Professional Services; Financial Services; Global Technology providers; Government Departments and Voluntary Agencies. Marie's career has spanned both public and private sector across Europe and has focused on training, facilitation, coaching, research. Her qualifications in Business, Education, Finance and Psychology, coupled with her previous experience in management of EU funded programmes, provides a competence for working in a variety of settings. She is currently completing Doctoral Studies on future skills in DCU. She is an external evaluator for European Education programmes. She is a member of the European Association for International Education (EAIE). Marie is a coaching psychologist with extensive experience as an executive coach and has worked at a senior level to assist clients resolve challenging issues, build resilience, enhance leadership capability and manage stakeholder needs.

#### **Prof Maurice Devlin**

Maurice Devlin is Professor in the Department of Applied Social Studies at Maynooth University, where he also holds the Jean Monnet Chair in European Youth Studies and is Co-Director of the Centre for Youth Research and Development. A native of Maghera, County Derry, he has been involved in youth work and youth services since childhood. He has contributed to youth policy development in Ireland and internationally and published widely on numerous aspects of youth studies. He was a founding director of BeLonG To - LGBTQ+ Youth Ireland. He was also founding joint chairperson of the North South Education and Training Standards Committee for Youth Work (NSETS). Maurice served two terms as Vice President for Europe of the Research Committee on Youth of the International Sociological Association and is Irish Correspondent for the European Knowledge Centre on Youth Policy. He is currently working as chief editor on the Elgar Encyclopedia of Youth Studies.

#### **Lorraine Gilligan**

Lorraine Gilligan is the Executive Director of Léargas, the National Agency for EU programmes in education, training, sport, volunteering and youth. Léargas aims to provide educational and learning experiences for young people; and supports organisations across Ireland to develop and exchange good practices through programmes and initiatives such as Erasmus+ and European Solidarity Corps.

#### **Adam Gunning**

Adam Gunning is an Assistant Principal Officer in the Youth Affairs Unit of the Department of Children, Equality, Disability, Integration, and Youth (DCEDIY). He has been in DCEDIY for 8 years, spending 5 years in Early Years and nearly 3 in Youth. Within the Youth Affairs Unit he has responsibility for youth information, ICT development, data and analytics, and parliamentary affairs.

#### **Paul Keating**

Paul Keating is a Researcher and Lecturer in the Technological University of the Shannon based in Tipperary. With a background in Engineering and Community Development he has worked as a Community Worker in Ireland, across the EU, East Africa and the Balkans for over 20 years. In recent years Paul has partnered with the National Youth Council of Ireland and Youth Work Ireland, exploring and developing the use of games in youth work practice particularly as it related to development education He has also partnered with international NGOs such as Trocaire in integrating games into their development education programmes.

#### Mark Malone

Mark leads research and communications with Hope and Courage Collective. He has been active in social movements for social, economic and ecological justice for over two decades. This has included work in community education, anti-racism, tax and debt justice and climate justice. Since 2014 Mark has also focused on understanding reactionary far right movements, and more recently the ways and means by which communities and civil society might better equip itself against these movements. Both of which are a core focus of HCC's work today"

### Michael McLoughlin

Michael Mc Loughlin is Head of Advocacy and Communications with Youth Work Ireland where he specializes in advocacy on the range of policy issues for young people and those who work with them. He is a former Chairperson of Leargas and Board member of the Children's Rights Alliance. He is a Government nominee to the European Economic and Social Committee where he has authored opinions on youth, education, employment, social policy and EU External Action as part of the EU legislative and policy process.

# **Aisling Moloney**

Aisling is a third-year Law with Politics student in UCD. She has worked on topics such as climate change, the SDGs and mental health through her involvement in Youth Work Ireland, both on a local and national level. She currently serves as our delegate to the National Youth Assembly of Ireland, and also works on both highlighting and increasing opportunities for other young people.

#### **Dan Moxton**

Dan is a researcher and practitioner specialising in inclusive youth participation with over 25 years experience working with children and young people in the voluntary, public, for-profit and academic sectors. His research focuses on how children and young people's participation can influence policy and practice, as well as the development of participatory structures and processes. Originally a youth worker at local and

regional level in the North West of England, he now works throughout Europe and beyond supporting a variety of organisations, to develop their approach to youth participation. He was recently the author of ERYICA and Eurodesk's guide on Youth participation in youth information services.

#### **Kate O'Connell**

Kate O'Connell an Equality and Intercultural programme officer with the National Youth Council of Ireland and over the last 12 months has been leading the programme work supporting youth services to respond the threat of the Far Right in Ireland. NYCI works closely with the Hope and Courage Collective to co-create responses for youth workers and community workers in Ireland. Kate has over a decade of experience in anti-racist activism and has worked across a number of local and national organisations promoting migrant integration and intercultural dialogue.

#### Dr Lorraine O'Donovan

Lorraine O'Donovan joined CDYS as their new CEO in March 2023. Prior to my appointment to CDYS, I was the Senior Executive at South Munster Citizens Information Service, leading the restructuring of five services in Cork and Kerry into one strong, streamlined service. I enjoyed working with Le Chéile Mentoring and The Probation Service to support young people and families involved with the Justice system. My background also includes youth and community work, the delivery of parenting programmes and family support work as well as the development of best practice materials to support you and community workers as well as funders.

#### **Mathieu Orphanides**

Mathieu Orphanides is a Cypriot national living in Brussels and working for the European Commission. He graduated in marketing and started his professional career in an advertising company. He joined the European Commission in 2002, first in the HR department dealing with finances and budget during 4 years, then he was recruited in the DG for Education, Youth, Culture and Sport (DG EAC). In DG EAC, he worked in several departments: resources, budget/finance and National Agencies. In 2016 he joined the youth unit in DG EAC as Programme Manager for Erasmus+ and European Solidarity Corps. He is currently in charge of SALTO Participation & Information, Eurodesk and ERYICA. He is also responsible for the development and the implementation of the DiscoverEU action and the general coordination of the European Youth Week 2024.
